1. Introduction

This Quick Start Guide will provide you with the information you need in order to understand how to file a Web-based ADS, including a brief overview of the process and screen shots that identify critical aspects of the submission.

EFS-Web will automatically generate and attach a PDF version of the Web-based ADS.

2. Basic Guidelines for Filing a Web-based ADS

- You must be able to access EFS-Web.
- The Web-based ADS is available for new applications under the following submission types: Utility and Designs.
- The Web-based ADS is not permitted in PCT and Supplemental Examination submissions
- You can be either a Registered or Unregistered eFiler. Only Registered eFilers may save a submission as a work-in-progress for up to 7 days.
- The Web-based ADS is not permitted in follow-on submissions.
- The Application Data Sheet must be signed in accordance with 37 CFR 1.33(b). If an applicant is prosecuting the application pro se, all of the inventors must sign to comply with the rule, unless a power of attorney has been given (e.g., Form PTO/AIA/81). See MPEP 402.
- All required fields must be completed in order to proceed with the submission. The required fields are indicated with an asterisk (*).
- A Web-based ADS can only be submitted with the filing of a new application on or after September 16, 2012, or with a U.S. national stage entry under 35 U.S.C. 371 where the Patent Cooperation Treaty (PCT) filing date (international filing date) is on or after September 16, 2012. The pre-population feature will not work for national stage applications.
- Do not attach an ADS as a PDF if submitting a Web-based ADS.

- Submissions under a Secrecy Order may not be filed electronically.

Warning: EFS-Web sessions will time-out after one hour of inactivity. A Web-based ADS that has not been submitted or saved after one hour of inactivity will be lost. You will need to login to EFS-Web again and re-enter the information from the start.

3. Access the Web-based ADS

The Web-based ADS will only be displayed for new Utility and Design applications. It is currently not available for International or existing applications, or Supplemental Examination proceedings.

(This includes new filings of continuation, divisional, continuation-in-part and re-issue applications, as well as reexamination and supplemental examination proceedings. A request for continued examination (RCE) and continued prosecution application (CPA) are considered existing documents and must be filed as a registered eFiler.)

On the Application Data tab, the default selection is the Application Data radio button. In order to access the Web-based ADS, select the second radio button, “Web-based ADS.” This will expand the web screen and display the Web-based ADS fields. Based on the selection of the radio button, the data will be collected from either the Application Data fields or Web-Based ADS fields after the continue button, which is located at the bottom, is clicked. Any data entered in the non-selected form will not be retained.

Application Data

A submission has not been filed officially at the USPTO until the e-filer executes the Submit function and the documents are received at the USPTO Eastern Time. The Acknowledgement Receipt is evidence of this submission.
All items denoted by * are required.

Web-based ADS - An ADS form is auto-generated based on data entered on a web screen. A Web-based ADS can only be submitted with the filing of a new application on or after September 16, 2012, or with a U.S. national stage entry under 35 USC 371 where the Patent Cooperation Treat (PCT) filing date (international filing date) is on or after September 16, 2012. Do not attach an ADS as a PDF if submitting a Web-based ADS.
Based on the above selection of the radio button, the data will be selected from either the Application Data fields or Web-Based ADS fields after the continue button is clicked. Any data entered in the non-selected form would not be retained.

3.1 Application Information Retrieval

In the Application Information Retrieval section, users are presented with the option to pre-populate application information based on a previously filed application. Data may be retrieved for eFilers who either have power of attorney in the parent application or if the parent application is made available to the public, i.e., published or patented.

When using the pre-populate functionality, the first step is to enter the application and confirmation number of the parent application, then click the “**Show**” button. Bibliographic information of the entered application number is displayed for verification purposes. Information is to include:

- Parent Title
- Parent First Named Inventor
- Parent Filing Date

After verifying the bibliographic information, then the options to populate the following sections are available:

- Inventor Information
- Domestic Benefit/National Stage Information
- Foreign Priority Information

After successful retrieval the indicated sections will be filled with the USPTO’s data of record, if available.

NOTE: When retrieving Domestic Benefit/National Stage Information the entered parent information will be used as the first claim entry to the current application. You must enter the continuity type and status information for each application for which retrieval is requested. For example, if you request retrieval of a parent nonprovisional application, you will then need to select the relationship in the continuity drop-down of either continuation, divisional, or continuation-in-part.

Not all inventor information may be retrieved. The system can only retrieve information stored in the USPTO Patent Application Locating and Monitoring (PALM) system, and not all information or record in an application is entered and stored in PALM. If there are multiple inventors, the system

may only retrieve the mailing address of the first named inventor. If an EFS Web-based ADS or an uploadable PDF version of the ADS form has previously been used, all of the information should be stored in PALM.

In the Inventor Information section, the required fields are indicated by an asterisk. You will not be able to proceed if a required field is missing.

3.3 Correspondence Information

The correspondence section is a required section. A Customer Number or an address must be entered. The default field is the Customer Number. Registered eFilers will be able to select a Customer Number from the drop down menu or enter a Customer Number. Unregistered eFilers will only be able to enter the Customer Number. If you do not have a Customer Number, select the checkbox and the section will expand to allow an address to be entered.

3.4 Application Information

The Title of the Invention is a required field. Note: Special characters may not be entered in this field as it may not transfer correctly to USPTO databases.

Filing by Reference

This section is not for making domestic benefit or foreign priority claims. Do not complete this section if application papers including a specification and any drawings are being filed at the time of filing the application. Only complete this section when filing an application by reference under 35 U.S.C. 111(c) and 37 CFR 1.57(a), as provided for in the Patent Law Treaty (effective December 18, 2013). Any domestic benefit or foreign priority information must be provided in the “Domestic Benefit/National Stage Information” section and/or the “Foreign Priority Information” section, as appropriate. 3.8 Foreign Priority Information
