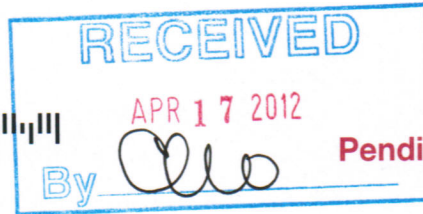

### SECTION 9 OF THE UNITED STATES TRADEMARKS ACT:

*An application for renewal **must be filed** within one year before the expiration of the registration.*

During the following time periods, the owner of the registration must file an affidavit or declaration of continued use or the registration will be cancelled:

- (1) On or after the fifth anniversary and no later than the sixth anniversary after the date of registration or
- (2) For all registrations, within the year before the end of every ten-year period after the date of registration.

Trademark Owners who have registered Trademarks with the United States Patent and Trademark Office (USPTO) are required to comply with the office maintenance schedule in order to maintain and keep the trademark(s) registered. A statement noting the requirement for the filing of the affidavits or declarations of continued use is included on each certificate of registration. The USPTO gives no further notice. However, the owner must file the affidavit or declaration within the time periods required by Section 9 of the Act regardless of whether the owner receives the notice. The USPTO does not provide any reminder of the due date(s) of the affidavits. If the affidavit is not filed before the deadlines, then a grace period of 6 months will be allowed for an additional fee, after that the trademark will **be cancelled** by the USPTO.
