

AMENDMENT #2 TO RFP 52PAPT201008

The purpose of this Amendment to Solicitation 52PAPT201008 is to: (1) provide responses to offeror questions/comments regarding the solicitation and (2) incorporate revisions to the Solicitation.

1. Amendment #2 hereby incorporates questions and answers 1 through 47 which are posted on the web page.
2. A revised Request for Proposal has been posted which reflects the following changes:
 - (a) Block 9 of the SF-33 is hereby amended to extend the proposal due date to May 7, 2002 at 2:30 p.m. EST.
 - (b) Sections B.4, C.3.2.1, C.3.2.4, and H.6 are hereby amended to correct typos.
 - (c) SECTION C – DESCRIPTIONS AND SPECIFICATIONS is hereby amended as follows:
 - i. Section C.3.2.1 is hereby amended to add a “bullet” that reads: “Determining if incoming correspondence files have been mis-scanned, using Government-supplied tools such as those available in the Trademark Image Capture and Retrieval System (TICRS) online supervisor module”; and
 - ii. Section C.3.2.4 is hereby amended to revise the requirements for Data Capture of New Application Information as shown in the revised RFP.
 - (d) Under SECTION E – INSPECTION AND ACCEPTANCE, Section E.1 is hereby amended to delete clause 52.246-06, Alt I.
 - (e) Under SECTION H – SPECIAL CONTRACT REQUIREMENTS, Section H.5, entitled “Government Identification/Suitability Investigations”, is hereby restated as reflected in the revised Request for Proposal.
 - (f) Under SECTION I – CONTRACT CLAUSES, Section I.1 is hereby amended as follows:
 - i. Delete clauses 52.207-03, 52.216-24, 52.216-25, 52-222-01, and 52.242-01;
 - ii. Add clause 52.249-06, Alt IV; and
 - iii. Delete clause 52.217-09 and replace in full text as Section I.5.
 - (g) Under SECTION K – CERTIFICATIONS AND REPRESENTATIONS, Section K.4 is hereby amended to change the size standard to \$21.0 million.
 - (h) SECTION L – INSTRUCTIONS, CONDITIONS AND NOTICES TO BIDDERS is hereby amended as follows:
 - i. Section L.8 is hereby amended to revise the anticipated award date to August 30, 2002;
 - ii. Section L.18 is hereby amended to clarify proposal requirements and mailing requirements and to extend the deadline for receipt of proposals to 2:30 p.m. local time on May 7, 2002; and
 - iii. Section L.19(c)(3) is hereby amended to clarify the deadline for receipt of past performance questionnaires and to advise offerors without a record of relevant past performance or for whom information on past performance is not available how their proposal will be rated.
 - (i) Under SECTION M – EVALUATION FACTORS FOR AWARD, the title of Section M.4 is hereby amended to “AWARD WITHOUT DISCUSSIONS”.
