## ANNUAL INDEX OF PATENTS ISSUED FROM THE U.S. PATENT AND TRADEMARK OFFICE

The *Annual Index of Patents Issued from the U.S. Patent and Trademark Office* includes cumulative indexes by classification, patentee name, and geographical location as well as all Official Gazette - Patents records for each year, on one DVD-ROM disc. Unlike the paper Annual Index of Patentees in past years, which only indexed patents by patentee and classification, the electronic version includes the bibliographic record as well. Each record consists of bibliographic information, a representative claim, and a drawing (if applicable) of each patent issued during the year. Patents are accessible by type of patent (utility, plant, etc.), classification (by class or alphabetically), patentee name, and geographical location (including foreign countries). Links enable users to “jump” to a specific patent from these various indexes.

In addition to the indexes and individual bibliographic records, this product includes the following:

- all Patent and Trademark Office Notices published during the year
- the Consolidated Listing of Official Gazette Notices Re-Patent and Trademark Office Practices and Procedures - a compilation of the most important notices and rule changes which have been published in the Official Gazette from July 1, 1964, through the end of each year
- a listing of Patent and Trademark Depository Libraries (PTDLs)
- a listing of Federal Depository Libraries which receive the Official Gazette and other patent and trademark products
- a listing of the Foreign Industrial Property Offices and International Entities, which receive one or more sets of U.S. patent documents
- a summary of the number of Patents, Defensive Publications, and Statutory Invention Registrations issued from 1836 through the end of each year
- a listing of all patent numbers which have no associated patent, and Reexamination Certificates for which no Reexamination exists
- a list of document numbers for each patent type, as they appeared in the 53 individual issues of the Official Gazette
