### **ICANN** updates

- ICANN75 (Internet Corporation for Assigned Names and Numbers)
  Annual General Meeting on Sept. 17-22:
- Ongoing debates over defining "DNS Abuse," with greater emphasis on enhanced abuse reporting
- "WHOIS Disclosure System" introduced, allowing for the consolidated approach to making requests for information
- No mention of anticipated review of Uniform Domain Name Dispute Resolution Policy (UDRP)
- ICANN still reviewing plans for new round of gTLDs, possibly now in 2026

### WIPO SCT updates

- Standing Committee on the Law of Trademarks, Industrial Designs and Geographical Indications (SCT) will meet from November 21-23, 2022
- Trademarks and Geographical Indications
  - Discussion on protection for country names in trademarks and in generic top-level domains ("gTLDs"), and countries' development, use, and enforcement of nation brand
  - GI information session on the margins. Future GI information sessions and a proposed nation-brand protection session to be discussed further

#### Industrial Designs

- Matters concerning the convening of a diplomatic conference of a Design Law Treaty (DLT)
- Updated proposal for a joint recommendation concerning industrial design protection for designs for graphical use interfaces (GUIs)

### WIPO Madrid working group update

- Annual meeting is on November 7 11, 2022
- Significant topics:
  - Dependency and the possible convening of Diplomatic Conference
    - TPAC preliminary feedback indicated interest in eliminating the basic mark requirement rather than reducing dependency period from 5 to 3 years
  - Adding new languages (Arabic, Chinese and Russian)
  - Examining limitations for scope, filed in international applications

### TM5

- TM5 Annual Meeting was held from October 24-26, 2022, in Brussels, Belgium.
- A full-day TM5 user session was held on October 26.
- 2021 annual statistics for each Partner office and new TM5 reports and statements are available at tmfive.org.
