## Trademark initial application form

In the Trademark Electronic Application System (TEAS), we have one initial application form with two filing options: TEAS Plus and TEAS Standard.

- The **TEAS Plus** filing option has more requirements up-front when you submit your initial application. As a result, you pay a lower fee of \$250 per class of goods/services.
- The **TEAS Standard** filing option has fewer requirements up-front. However, you must eventually meet all the application requirements and pay a higher fee of \$350 per class of goods/services.
