DTD Element Name: trademark-assignment, Description: Parent element for text file. DTD

Element Name: version, Description: Group element comprised of version-no and version-date. DTD Element Name: version-no, Description: Indicates release number for DTD. DTD Element Name: version-date, Description: Indicates release date of DTD. DTD Element Name: transaction-date, Description: Indicates date data was extracted on. DTD Element Name: action-key-code, Description: Indicates content of file relates to either a daily, weekly or annual release. DTD Element Name: assignment-information, Description: Group element comprised of data-available-code or assignment-entry. Contains all data extracted for time period shown in action-key-code. DTD Element Name: data-available-code, Description: When present indicates no data available for date shown in transaction-date-element. DTD Element Name: assignment-entry, Description: Group element comprised of assignment, assignors, assignees, properties. Indicates start of next assignment record. DTD Element Name: assignment, Description: Group element comprised of the following child elements reel-no, frame-no, last-update-date, purge-indicator, date-recorded, page-count, correspondent, conveyance-text. DTD Element Name: Reel-no, Description: 1-6 digit number identifies the reel number to be used to locate assignment on microfilm. DTD Element Name: frame-no, Description: 1-4 digit number that identifies the frame number to used to locate the first image (page) in the assignment. DTD Element Name: last-update-date, Description: An 8 digit date (YYYYMMDD format) identifies when the assignment record was last modified. DTD Element Name: purge-indicator, Description: Indicates when an assignment record has been deleted from the Historical database. DTD Element Name: date-recorded, Description: An 8 digit date (YYYYMMDD format) identifies when the assignment was recorded in the USPTO. DTD Element Name: page-count, Description: Identifies the total page count of which the assignment contains (number of pages captured on microfilm). DTD Element Name: conveyance-text, Description: Contains textual description of the interest conveyed or transaction recorded. DTD Element Name: correspondent, Description: A group element comprised of person-or-organization-name, address-1, address-2, address-3, address-4. DTD Element Name: person-or-organization-name, Description: Identifies the name of a person or organization to where correspondence related to the assignment is to be directed to when the element appears in the correspondent group element. DTD Element Name: address-1, Description: Typically identifies 1<sup>st</sup> line of delivery address provided for the person-or-organization-name (may also be a person-or-organization-name such as firm name, etc.). Data values provided are those that are supplied by the submitter of the assignment document. DTD Element Name: address-2, Description: Typically identifies 2<sup>nd</sup> line of delivery address provided are those that are supplied by the submitter of the assignment document. DTD Element Name: address-3, Description: Typically identifies 3<sup>rd</sup> line of delivery address provided are those that are supplied by the submitter of the assignment document. DTD Element Name: address-4, Description: Typically identifies 4<sup>th</sup> line of delivery address provided for the person-or-organization-name (if present will probably identify city, state/country, postal code information). Data values provided are those that are supplied by the submitter of the assignment document. DTD Element Name: assignors, Description: A root element that contains one or more element(s) assignor. DTD Element Name: assignor, Description: Group element that contains person-or-organization-name, formerly-

statement, dba-aka-ta-statement, composed-of-statement, address-1, address-2, city, state, country-name, postcode, execution-date, date-acknowledged, legal-entity-text, nationality. DTD Element Name: person-or-organization-name, Description: Identifies the party (person or organization name) conveying an interest or transaction in a registered mark or a mark for which an application to register has been filed. DTD Element Name: formerly-statement: A statement that identifies the party name under which the assignor party previously operated. DTD Element Name: dba-aka-ta-statement, Description: A statement that identifies the party name under which the assignor party is operating. The appropriate acronym (dba, aka, ta) is precedes the text statement. DTD Element Name: composed-of-statement, Description: A statement that identifies all parties comprising the assignor party name. DTD Element Name: address-1, Description: Typically identifies 1<sup>st</sup> line of delivery address provided for the person-or-organization-name (may also be a person-or-organization-name such as firm name, etc.). Data values provided are those that are supplied by the submitter of the assignment document. DTD Element Name: address-2, Description: Typically identifies 2<sup>nd</sup> line of delivery address provided are those that are supplied by the submitter of the assignment document. DTD Element Name: Execution-date, Description: Contains an 8 digit date (YYYYMMDD format) indicating date on which the supporting legal documentation was executed. DTD Element Name: date-acknowledged, Description: Contains an 8 digit date (YYYYMMDD format) indicated date on which the supporting legal documentation was executed. DTD Element Name: date-acknowledged, Description: A textual description describing the party's legal entity status. DTD Element Name: nationality, Description: A textual description defining the party's state of incorporation or nationality. DTD Element Name: assignees, Description: A root element that contains one or more element(s) assignor. DTD Element Name: assignee, Description: Group element that contains person-or-organization-name, formerly-statement, dba-aka-ta-statement, composed-of-statement, address-1, address-2, city, state, country-name, postcode, execution-date, date-acknowledged, legal-entity-text, nationality. DTD Element Name: person-or-organization-name, Description: Identifies the party (person or organization name) receiving an interest or transaction in a registered mark or a mark for which an application to register has been filed. DTD Element Name: address-1, Description: The person or organization name 1<sup>st</sup> line of address (typically the street address component of a mailing address). DTD Element Name: address-2, Description: The person or organization name 2<sup>nd</sup> line of address (typically the street address component of a mailing address). DTD Element Name: city, Description: The person or organization name city component of a mailing address. DTD Element Name: state, Description: The person or organization name state name (for US states) component of a mailing address. DTD Element Name: country-name, Description: The person or organization name country name (for non US states) component of a mailing address. DTD Element Name: postcode, Description: The person or organization name postal code component of a mailing address. DTD Element Name: properties, Description: A group element comprised of serial-no, registration-no, trademark-law-treaty-property and international registration-number. DTD Element Name: property, Description: Repeating group element comprised of serial-no, registration-no, trademark-law-treaty-property, international registration number. DTD Element Name: serial-no, Description: A four-to-seven digit number assigned to a registered trademark application. DTD Element Name: trademark-law-treaty-property, Description: A group element

DTD Element Name: tlt-mark-name, Description: A textual description provided by the submitter (generally used when the submitter has not received a filing receipt for a recently filed TM application). DTD Element Name: tlt-mark-description, Description: A textual description provided by the submitter describing the mark (may be used instead of mark-name for filing an assignment. DTD Element Name: international-registration-number, Description: A 10 digit alphanumeric number assigned by the International Bureau.
