<p>Utility Patents</p> <p>Utility patents are found electronically on the USPTO's PatFT, PubWEST and PubEAST search systems. Earlier methods of providing utility patents included CASSIS USAPat (Optical discs) (2000 – 2011) and microfilm (1983 – 1999). The earliest distribution of utility patents to the patent depository libraries was in paper. (1870-1983). For PTRCs with microfilm collections this format acts as the best archival source and a resource for patent images where the electronic version is poorly scanned.</p>	Various
<p>Design Patents</p> <p>Design patents are found electronically on the USPTO's PatFT, PubWEST and PubEAST search systems. Earlier methods of providing design patents included CASSIS USAPat (Optical discs) (2000 – 2011) and microfilm (1983 – 1999). The earliest distribution of design patents to the patent depository libraries was in paper. (1870-1983). For PTRCs with microfilm collections this format acts as the best archival source and a resource for patent images where the electronic version is poorly scanned.</p>	Various
<p>Plant Patents</p> <p>Due to the importance of color rendition of plant patents they are retained in paper format. They can be searched via the electronic databases, the USPTO's PatFT, PubEAST and PubWEST search systems however the images are only black and white. Plant patents are also found on the discontinued CASSIS USAPat (optical discs) (2000 – 2011) but again those images are only black and white. Plant patents were temporarily distributed on color microfiche, from 1991 – 1999 which included the entire backfile.</p>	Various
<p>Published Patent Applications (Start Date: Apr. 2001)</p> <p>Published patent applications are electronically on the USPTO's AppFT, PubEAST and on PubWEST. They are also available on the discontinued CASSIS USAApp (Optical discs) (2001 -2011).</p>	Various
<p>Statutory Invention Registrations (Sirs)</p> <p>Statutory Invention Registrations or SIRs replaced the Defensive Publications in 1985. With the beginning of published patent applications the use of SIRs diminished and were repealed with the America Invents Act of 2011 (effective March 16, 2013). They are available on the USPTO's PatFT, PubWEST and PubEAST search systems. SIRs are available on CASSIS USAPat (Optical discs) (2000 – 2011) and they along with the Defensive Publications are also available on the microfilm (1983-1999).</p>	Various
<p>Certificates Of Correction</p> <p>Certificate of corrections are appended to the back of the patents they correct on the USPTO's PatFT, PubWEST and PubEAST search systems. They are included on the discontinued CASSIS USAPat (Optical discs) (2000 – 2011). They are also available on separate reels of microfilm called CDRs (Corrections, Disclaimers and Reexaminations) (1983-1999).</p>	Various
<p>Reissue Patents</p> <p>Reissue patents are available on the USPTO's PatFT, PubWEST and PubEAST search systems. They are available on the discontinued CASSIS USAPat (Optical discs) (2000 – 2011). They are also available on separate reels of microfilm called CDRs (Corrections, Disclaimers and Reexaminations) (1983-1999).</p>	Various

<p>Trademark Registrations</p> <p>Trademark registrations are available on the USPTO Website on the Trademark Status and Document Retrieval (TSDR) database. They are also available on the discontinued CASSIS USAMark (Optical discs) (2000 – 2011).</p>	Various

<p>Annual Index and Cumulative Electronic Official Gazette (various titles)</p> <p>The Annual Index of Patents formed the basis for inventor name searching; it ceased publication in paper in 2002. With the ability to electronically search inventor names back to 1920 (PatFT, PubWEST, PubEAST and the Cumulative Annual Index of Patents issued on CASSIS optical discs from 2001 – 2010) only the paper indexes and annual reports for years prior to 1920 should be retained by PTRCs to provide inventor name searches for earlier years.</p>	Various
<p>Official Gazette of the USPTO</p> <p>The Official Gazette of the United States Patent and Trademark Office began being published every Tuesday in 1872. In July 1971 the publication was split in two separate publications, one Official Gazette Patents and the other the Official Gazette Trademarks. The Official Gazette Patents ceased printed publication on September 24, 2002 and continues being published on Tuesdays electronically (eOG) on the USPTO website. The Official Gazette Trademarks ceased being published in paper (for subscription copies) in 2012. Published electronically on Tuesdays on the USPTO website since 2001. Distributed on optical discs July 2, 2002 to December 27, 2011.</p>	Paper, Optical Disc
