# USPTO STUDY ON PATENT PRO BONO PROGRAM: LISTENING SESSION FOR PATENT LAWYERS AND AGENTS

#### **Derrick Brent**

Deputy Under Secretary of Commerce for Intellectual Property and Deputy Director of the United States Patent and Trademark Office

Derrick Brent is the Deputy Under Secretary of Commerce for Intellectual Property and Deputy Director

of the United States Patent and Trademark Office (USPTO). He serves as the principal advisor to Kathi Vidal, Under Secretary of Commerce for Intellectual Property and Director of the USPTO, for one of the largest intellectual property (IP) offices in the world, with more than 13,000 employees and an annual budget of more than \$4 billion.

Deputy Director Brent has served in all three branches of the federal government and the private sector. He clerked for the Hon. Algenon L. Marbley, Chief Judge of the U.S. District Court for the Southern District of Ohio, and served for six years as a Senior Trial Attorney at the U.S. Department of Justice, Civil Rights Division, where he received a Special Achievement Award for his trial work. Also, he served as a Chief Counsel in the U.S. Senate, where handled IP issues along with other areas such as constitutional law, civil rights, and judicial nominations.

Deputy Director Brent's experience in the private sector includes serving as Vice President/Associate General Counsel for Masimo, on the leadership team at Cut Golf, and as an engineer at General Motors.

Deputy Director Brent received a Bachelor of Science degree in mechanical engineering from The Ohio State University and a Juris Doctor degree from the Northwestern University School of Law (now the Northwestern University Pritzker School of Law).



David L. Berdan

#### **General Counsel**

As United States Patent and Trademark Office's (USPTO) General Counsel, David L. Berdan serves as the principal legal advisor to the Under Secretary of Commerce for Intellectual Property and Director of the USPTO. Mr.

Berdan also supervises the Office of General Counsel and its three component offices: the Office of the Solicitor, the Office of General Law, and the Office of Enrollment and Discipline.

Mr. Berdan is a graduate of the U.S. Military Academy at West Point, where he earned a Bachelor of Science in engineering and co-captained the Army football team as a defensive back. He is a combat veteran of Operation Desert Storm and is the recipient of numerous military awards, including a Bronze Star. Mr. Berdan has a Juris Doctor from Drake University Law School, where he was a founding member and President of the Drake Intellectual Property Law Society.

Over the past 26 years, Mr. Berdan has served in a variety of important legal positions, including as Patent Counsel at Corning, Inc., as Vice President and Intellectual Property Counsel at The Coleman Company, as Chief Counsel Intellectual Property at INVISTA, as Vice President Legal and Deputy General Counsel at International Game Technology, and, most recently, as General Counsel and Compliance Officer of Gaming Arts. Mr. Berdan also spent two years as an engineer and seven years in private law practice.



### James Silbermann

Senior Counsel for Enrollment and Intellectual Property Legal Services Office of Enrollment and Discipline

James M. Silbermann is USPTO's Senior Counsel for Enrollment and Intellectual Property Legal Services in the Office of Enrollment and Discipline. He leads a team of attorneys that is responsible for all aspects of enrollment to practice before the USPTO, including development of the registration examination to measure an

applicants' knowledge of patent law and practice. He also is responsible for oversight and management of the USPTO Patent Pro Bono and Law School Clinic Certification Programs. Mr. Silbermann is also responsible for Office of Enrollment and Discipline rulemaking and other non-disciplinary matters.

Prior to becoming Senior Counsel, Mr. Silbermann was a staff attorney in the Office of Enrollment and Discipline handling enrollment and discipline matters and also supervising the Law School Clinical Certification Program. Before joining USPTO in 2005, Mr. Silbermann worked at the law firm of Dickstein Shapiro Morin & Oshinsky LLP in Washington, D.C. and the Washington, DC office of Foley & Lardner LLP, where he specialized in intellectual property acquisitions, patent litigation and prosecution, and client consultation.

Mr. Silbermann received his B.S. degree in Chemical Engineering from the University of Maryland, College Park, and his J.D. degree, magna cum laude, from the Catholic University of America, Columbus School of Law, where he was an editor of the Journal of Contemporary Health Law and Policy.

## Vice Chief Judge for Engagement at the Patent Trial and Appeal Board

Janet Gongola manages internal and external engagement on behalf of the PTAB, including development of educational programs and PTAB

procedures and rules. She was appointed to the PTAB in October 2016. Before joining the Board, Judge Gongola was the Senior Advisor to the Under Secretary and Director of the USPTO where she advised on all matters of law and policy.

Judge Gongola also served as the Patent Reform Coordinator and managed the agency's implementation of the America Invents Act. She likewise was the Associate Commissioner for Patent Examination Policy and developed patent policy for the agency. Judge Gongola started her USPTO career as an Associate Solicitor providing legal advice to agency officials and defending decisions of the Patent Trial and Appeal Board before the U.S. Court of Appeals for the Federal Circuit and district courts.

Before joining the USPTO, Judge Gongola served as a law clerk for the Honorable Paul R. Michel at the U.S. Court of Appeals for the Federal Circuit and for the Honorable Judge Sue L. Robinson at the U.S. District Court for the District of Delaware. In addition, Judge Gongola worked as a patent attorney, patent agent, and research chemist at Eli Lilly and Company in Indianapolis, Indiana.

#### **Executive Director – Federal Circuit Bar Association**

Ms. Miron brings to the FCBA a wealth of legal and managerial experience through a long, distinguished career as judge, executive, litigator, and dedicated public servant for the United States Government. From 2002-2020, she served as Director of Regional Operations and Chief Administrative Judge of the United States Merit Systems Protection Board (MSPB), whose primary reviewing court is

the United States Court of Appeals for the Federal Circuit. In that capacity, she had legal and supervisory oversight of the agency's regional offices, where more than 60 Administrative Judges are charged with hearing and issuing decisions in over 5,000 federal employment appeals each year. She also coordinated the agency's Mediation Appeals Program. She was appointed a member of the Advisory Council for the United States Court of Appeals for the Federal Circuit.

Earlier in her career, Ms. Miron was a civil trial litigator in federal and local courts on behalf of the District of Columbia, supervisory attorney of a law students in court program, and attorney for the United States Commission on Civil Rights. She received her B.A. magna cum laude from the State University of New York at Buffalo, where she was elected to Phi Beta Kappa, and from which she also received her J.D. She was a Senior Executive Fellow at the John F. Kennedy School of Government at Harvard University, and selected as a member of the Senior Executive Service of the United States of America.

Ms. Miron is the recipient of numerous awards including MSPB's highest honor, the Theodore Roosevelt Award. She received the U.S. Attorney for the District of Columbia's Justice for Victims of Crime Award, presented to her by former United States Attorney General Eric Holder, for extraordinary assistance to her employee who was the victim of stalking and violent assault, that enabled the Department of Justice to prosecute the stalker and saved the life of the victim. Ms. Miron was made an Honorary Tailhooker by virtue of having catapulted off a U.S. Navy carrier. She received the Navy Superior Civilian Service Award and twice received the Navy Medal for Meritorious Civilian Service.
