

Invitation to Participate in Roundtables on Examination Time Goals

The USPTO recently began an initiative to conduct a holistic study of examination time goals. The Office published a Federal Register Notice on October 25, 2016 to announce the effort to external stakeholders and obtain their feedback.

The last assignment of expectancies for examination time was over 40 years ago, with only two minor adjustments during that time. Over the years, significant changes to the examination process have occurred, including increased complexity of application subject matter, exponential growth of available prior art, increased demand for more detailed office actions, use of electronic tools and changes in interpretation of law due to court decisions. In addition, because the current examination time goals were assigned based on the United States Patent Classification system, the USPTO's transition to the Cooperative Patent Classification (CPC) has caused the Office to reassess the assignment of examination time goals. Further, the Office's commitment to enhanced quality continues to shape best practices for examination time. All of these factors will be assessed in our wide reaching effort to analyze examination time.

Of course, no endeavor of this magnitude would be complete without hearing from our stakeholder community. The Office plans to use the public feedback as an input to help ensure that the Office's examination time goals accurately reflect the amount of time needed by examiners to conduct quality examination in a manner that responds to stakeholders' interests.

The ETA Outreach effort will include a series of interactive roundtable events to share ideas, feedback, and experiences. Each event will consist of a:

- Panel presentation on the use of examination time goals in the context of individual examiner evaluation and as an input into the model used to forecast pendency and hiring needs.
- Forum for informal and interactive discussion on the insights and interests of attendees with respect to examination time goals and quality, pendency, cost for services, and/or other topics related to the Request for Comments that may be informative.

The Roundtable events will be conducted in Alexandria, Virginia; Dallas, Texas; Detroit, Michigan; Denver, Colorado; and San Jose, California.
