

## INVITED SPEAKER CONFLICT OF INTEREST POLICY STATEMENT

Thank you very much for your interest in speaking at the United States Patent and Trademark Office (USPTO). The USPTO encourages presentations by invited speakers, as they help increase the general knowledge and expertise of USPTO employees and keep them informed about new developments in their areas of expertise.

The USPTO seeks to avoid any conflicts of interest. Accordingly, all speakers coming to the USPTO must first sign the Invited Speaker Conflict of Interest Policy Statement below.

The USPTO employs many people who telework and have flexible work schedules. To make presentations available to teleworking employees, the USPTO requires that all speakers consent to having their presentations simultaneously webcasted and recorded for future viewing. As part of your participation in the USPTO's PETTP program, your presentation may be made available to examiners who are participating in the training program as part of an MOU with the Canadian Intellectual Property Office (CIPO) and/or the Mexican Institute of Industrial Property (IMPI), in addition to examiners at the USPTO.

I confirm that I am aware of the USPTO's conflict of interest policy.

I confirm that I will not knowingly discuss any legal issue, technical issue, or subject matter specific to any case or matter currently pending before the USPTO with which I am involved, including any of my individual patent or trademark applications, those of my employer or business affiliates, or those of any third party.

With respect to any patent applications and other patent matters, I am aware that any material presented or distributed during my presentation will not be treated as "confidential" under 35 USC § 122, and may be releasable under the Freedom of Information Act (FOIA).

I confirm that I have offered and agreed to serve without compensation, and I explicitly waive any and all claims against the Government on account of my presentation.

I understand that as part of the USPTO's efforts to accommodate teleworking employees, presentations may be simultaneously webcasted or otherwise made contemporaneously available to remotely working employees. I understand that the USPTO will record my presentation for such purposes.

\_\_\_ Yes, I HEREBY CONSENT to the recording and preserving of my presentation. I understand that by signing this release and waiver, I am granting the USPTO the non-exclusive right in perpetuity to record the audio and/or video of my presentation and use that recording for future training/education purposes on a royalty-free basis at any time following the presentation.
