

	Feature/Functionality	Issue
1	AIA Review	Document section of AIA Review page may display Petitioner in the column header rather than Filing Party.
2	AIA Review	On the AIA Review page the Counsel type (Lead/Backup) may be blank, review the Power of Attorney document for additional information.
3	AIA Review	In the document section of the AIA Review the page count for documents filed through PRPS will show a "-".
4	Counsel Edit	External User cannot update Counsel Information. Send email to PTABE2EAdmin@uspto.gov to request update.
5	Dashboard	Information on the Dashboard may be inconsistent. "My Docket" displays a comprehensive listing of all AIA Reviews.
6	Document Management	Dropdown to select paper type when uploading documents may not include all appropriate paper types. Select the closest paper type available or "Other" and email PTABE2EAdmin@uspto.gov with the AIA Review number and paper or exhibit number and the desired paper type.
7	Document management	Users may encounter an intermittent error when attempting to upload a document. If the error is received the user should select add to re-attempt the upload until they receive a successful document upload message.
8	Enter Appearance As Patent Owner Wizard	When entering an Appearance as Patent Owner the wizard incorrectly interchanges Enter Appearance and Mandatory Notice. This wizard should be used for the Patent Owner to respond to the petition.
9	Enter Appearance As Patent Owner Wizard	When user selects "Enter Appearance as Patent Owner, the add button, in the Real Party section, is incorrectly labeled as "As Petitioner" and also labels the patent owner documents petition documents.
10	Enter Appearance As Patent Owner Wizard	Certification for Patent Owner submissions incorrectly states that a Power Of Attorney needs to be filed with each document submission. Additional Power of Attorney is only necessary if the new counsel has not been included on a previously filed Power of Attorney.

11	Fee Payment	If you receive an error message after selecting the "Pay" button please wait and try to submit again later. Your documents and data have been saved but the USPTO financial management system is unavailable. Try to "Pay" again during regular business hours. If you are attempting to meet a deadline and are unable to pay and submit your petition please email PTABE2EAdmin@uspto.gov or call 571-272-7822 for assistance.
12	Filter	External user may experience some unusual results when using the filter search on any table or grid.
13	Initiate Petition Wizard	Users will not see a listing of the documents uploaded nor added counsel in the expected area under the entry field until they refresh the page or navigate to another section of the wizard and return.
14	Initiate Petition Wizard	Paper numbers are assigned upon submission, they will not be displayed in the documents table until after submission.
15	Initiate Petition Wizard	During petition initiation, if the petitioner uploads a "Board Only" document, does not submit the petition and ends the current session, when returning to the initiated petition wizard the Board Only document will not be viewable and will need to be uploaded again.
16	Initiate Petition Wizard	On enter Counsel section of the Petition Creation Wizard, search by registration or email address before entering any data below that field.
17	Motions, Request for Rehearings, and AIA Review Appeals	Currently once an external party files a Motion, Request for Rehearing, or AIA Review Appeal the Motion, Request for Rehearing, or AIA Review Appeal will not display on the expected tab in the docket. All AIA Reviews are available on the All AIA Reviews tab located on "My Docket". Select the AIA Review to display the documents. To view the status of the Motion or Request for Rehearing select "AIA Review Actions." Future change - the Motions and Requests for Rehearings will be located on the respective tab under "My Docket"

	Feature/Functionality	Issue
18	Navigation Bar	External user - selecting the home icon incorrectly takes user to login page, do not select the home icon.
19	Notifications	Notification content may be incongruous. Notifications are used to inform the parties that an action has occurred, please open the AIA Review case from "My Docket" to review the content on the AIA Review page for additional information.
20	Paper Type for Motions	Users will be presented with a list of incorrect Motion Paper Types for selection when filing a Motion. User should select the correct paper type of Motion, Opposition, Reply, or Other. Do not select any of the other paper types from the drop down list.
21	Petition Creation Wizard and Patent Owner Appearance Wizard	When initiating a petition or patent owner appearance the paper type is not displayed for uploaded documents in the Documents table before the petition submission, however it will be displayed after the petition is submitted.
22	Search	Full Text Search is not available, Search by AIA Review, Patent, and Patent Application number as well as party name is available.
