## Parking (Headquarters and Regional Offices)

### Alexandria:

Parking is available in the East and West garages on a daily basis. To enter into the East Garage, enter at 551 John Carlyle Street and in the West Garage, enter at 550 Elizabeth Lane. The cost of parking for the entire day is \$10.00. You may validate your parking ticket with the security personnel for a discounted rate.

### San Jose:

There are a number of parking garages located within a few blocks of San Jose City Hall that USPTO employees, contractors, and visitors can use.

***Note: street parking on all sides of San Jose City Hall is prohibited.***

- **Fourth Street Garage;** 44 S. Fourth Street; (408) 279-8782;  
Monthly: \$100 (non-resident); Daily max: \$20
- **Second & San Carlos Street Garage;** 280 S. Second St.;  
(408) 298-8852; Monthly: \$100 (non-resident); Daily max: \$20
- **Third Street Garage;** 95 N. Third Street; (408) 794-1090;  
Monthly: \$100 (non-resident); Daily max: \$20
- **Third & Santa Clara Street Garage;** 25 S. Third Street;  
(408) 314-8249; Monthly: \$110 (non-resident); Daily max: \$20

### Denver:

While parking is not available in the Byron G. Rogers Federal Building for USPTO employees or visitors, there are a number of parking garages located within just a few blocks of the building which are listed below. Employees are responsible for obtaining parking as needed. Metered parking is also available on the side of the building for \$1/hour with a 2- hour maximum.

*Nearby Daily and Monthly Parking:*

- Ambassador Parking Management offers surface parking at the corner of 20th Street and Champa Street; \$8/day, \$120/month; telephone: 303-972-4510
- Century Link Building at 1890 Stout Street offers garage parking at \$14/day (early bird rate is \$8/day - in by 9 a.m., out by 7 p.m., first-come, first-served); \$180/month with one-time \$25 activation fee; telephone: 303-292-6126

- 24-Hour Public Parking offers surface parking at the corner of 20th Street and Stout Street directly across from the Byron G. Rogers Federal Building; \$8/day, no monthly parking

## **Detroit:**

Parking is free for all USPTO employees and contractors. Until the building has issued you a badge/decal, please give the guard your name and you will be admitted for free parking.
