The Right Time for a Greater Focus on Quality

- America Invents Act (AIA) provides a stable budget to pursue quality initiatives
- USPTO continues to reduce patent application inventory/pendency and improve IT infrastructures
- Dramatic changes to IP landscape
 - Abusive Litigation Practices
 - AIA Trials



Enhanced Patent Quality Initiative

Federal Register Notice (February, 2015) outlined the EPQI and requested comments

- EPQI is built around three patent quality pillars:
 - Excellence in Work Products
 - Excellence in Measuring Patent Quality
 - Excellence in Customer Service
- ❖ Began with six initial proposals, or ideas, to help enhance patent quality

Applying the Lessons of the Pilot

Leveraging the pilot to determine “best practices”:

- Measure the benefits of documenting claim interpretation, reasons for allowance, and enhanced interview summary
 - Using clarity metrics
- Determine the resources associated with the benefits
 - (additional time spent in recordation)
- Pilot examiners will share experiences
 - What worked and what didn't?
 - What feedback from applicants in responses?
- The “best practices” are those good practices that most effectively use examination resources.
