> **ORDER** Staying the Proceeding

On March 30, 2023, I issued a *sua sponte* Director review decision in this proceeding. Paper 13 ("Decision"). My Decision followed the earlier requests of Wolfspeed, Inc. ("Petitioner") for rehearing (Paper 10) and Precedential Opinion Panel ("POP") review (Ex. 3001) of the Board's decision denying institution (Paper 9), both of which were dismissed by the POP concurrently with my Decision (Paper 14).

In my Decision, I vacated the Board's decision denying institution and remanded the proceeding to the Board for further proceedings consistent with my Decision. Paper 13, 2–3.

ORDERED that the underlying proceeding is stayed pending my decision on Patent Owner's rehearing request.
