## Re: Comments to February 5, 2018 updates on additional materials for 2014 IEG

Dear Under Secretary Iancu, Under Secretary Scardino, and Commissioner Hirshfeld:

Thank you for inviting comments and providing the opportunity for the public to partake in improving the USPTO's guidance on Subject Matter Eligibility. We greatly appreciate your willingness to read our written suggestions.

Our comments are directed to the two new supplementary documents updated to the website on Subject Matter Eligibility:

- (1) The quick reference sheet on decisions holding claims eligible and identifying abstract ideas.
- (2) The chart of subject matter eligibility court decisions.

These materials provide extremely useful information for practitioners and others having interest in the area. Nevertheless, the materials would be even more useful if the following improvements are made to the documents:

## Quick reference sheet

The current version of the Reference sheet provides a list of court cases in parentheses on the topic. However, there is no indication whether the court decided for or against patent subject matter eligibility. subject matter eligibility court decisions). However, the Reference sheet would be even more useful if the parenthetical reference to the court case could also indicate whether the court ruled for or against eligibility.

## Chart of subject matter eligibility

For this spreadsheet to be most useful, it should be quickly updated as soon as possible. We realize that the three new court decisisons that have been relased since the chart was first uploaded were altogether updated a month later, on February 5, 2018. We recognize the resource limitations at the USPTO, but for it to as be as up-to-date as possible, we do urge that this highly useful spreadsheet be updated within a few days of each new court decision.
