NOTICE OF NONCOMPLIANCE WITH SURVEY OF REGISTERED PRACTITIONERS

Pursuant to 37 C.F.R. § 11.11(a)(2), the Office of Enrollment and Discipline (OED) conducted a survey of the active registered practitioners whose registration numbers are between 35,000-39,999. The purpose of the survey, which began on June 30, 2014, is to ascertain whether the practitioners wish to remain on the register and/or whether they need to update their contact information with OED. A response is required from every practitioner under survey.

As of October 17, 2014, OED has not received any response from about 443 practitioners. Their names and last known business addresses are listed below. They are given 60 days to pay the delinquency fee set forth in 37 C.F.R. § 1.21(a)(9)(i), and to provide the requested information on a blue Data Sheet, on or before December 16, 2014. **Practitioners on the list below who fail to reply and provide the requested information will be subject to administrative suspension pursuant to 37 C.F.R. § 11.11(b).**
