We know that having a USPTO satellite office in the greater New Orleans, Louisiana region will provide greatly improved access to the USPTO, support Departmental objectives including *CommerceConnect*, and increase collaborations among Commerce bureaus throughout the southern states of the Austin and Atlanta Department of Commerce Economic Development Administration regions.

The Louisiana Incubation Association is comprised of the state's premier business incubators focused on creating jobs and developing local economies. As part of the incubation association, local incubators are able to capitalize on statewide partnerships and draw from a pool of resources.
