

How to Request a Foreign Application Under the Electronic Priority Document Exchange Programs

A request to electronically retrieve a foreign priority application is automatically recorded, and the priority document information is listed on the application filing receipt, when an applicant indicates a priority claim to an application filed with a foreign intellectual property office that participates in the electronic priority document exchange program with the USPTO.

In order to expedite processing of a request to retrieve and ensure that the first attempt to retrieve is successful, the applicant is strongly encouraged to:

- ✓ cite the foreign application using an acceptable format (presented below) and its filing date, and
- ✓ use proper and consistent citation format throughout the U.S. application.

An improper, incomplete, or inconsistent citation of a foreign priority application and/or its filing date will result in a delay or prevent retrieval under the Priority Document Exchange program. In particular, any foreign priority claim that is incomplete will prevent successful electronic retrieval of the priority application. When Option A is selected on form [PTO/SB/38](#), the foreign priority application identified for retrieval must be the same as the foreign priority application to which priority is claimed. Applicants are reminded that the applicant bears the ultimate responsibility for ensuring that the priority document is filed by the time of patent grant as required under 37 CFR 1.55.
