Dear Sir or Ma'am,

37 CFR 1.6(d)(2)(iii) requires facsimile transmission "to the specific facsimile transmission number identified by the Office" but fails to explain where such facsimile transmission numbers are to be found. I have been unable to find such a listing. The announcement of the proposed rule does not provide such listing nor explain where such listing may be found. Without a prominent listing the proposed rule effectively eliminates all facsimile practice, but does not so state. Facsimile transmission is important to those who do not file via EFS-Web and should be maintained.
