Opinion by Hairston, Administrative Trademark Judge:

The Board's opinion issued December 30, 2002 is hereby  
amended so as to clarify that the refusal to register in  
view of Registration No. 1,671,827 is affirmed with respect  
to the goods in Class 25 (footwear, namely flip-flops and  
aqua shoes) only. In view thereof, and inasmuch as the  
other refusals were reversed, the application will go  
forward with respect to the goods in Class 9 (sunglasses).
