- When multiple symbols are included in the "Transferred to" column, avoid using ranges of symbols in order to be as precise as possible.
- For administrative transfer of documents, the following text should be used: "< administrative transfer to XX>" or "<administrative transfer to XX and YY simultaneously>" when administrative transfer of the same documents is to more than one place.
- Administrative transfer to main trunk groups is assumed to be "invention information", unless otherwise indicated, and to 2000 series groups is assumed to be "additional information".
