- "Frame" means any member to which a wing may be held by a fastening device. It does not include a framework forming part of the wing, but it may be another wing;
- "Lock" means primarily a device for releasing or securing any member, which requires a key or a permutation mechanism for release. - "Bolt" means a sliding, pivoted, or otherwise movable member such as is normally carried by a door to hold it shut by engagement with a keeper on the frame. It may be operated by hand directly or through mechanism or by a key; it may be a

latch (see (5) below);

- "Latch" means a bolt arranged to be moved to the releasing position against the force of a spring, or some other returning force, when a wing meets the frame on closing, so that it does not have to be operated by hand to secure the wing, but only to

open it;

- "Hasp" means a member hinged to the frame or wing so that it can be moved towards the face of the wing or frame and secured thereto, e.g. by a turn-button, by a padlock and staple.
